ABOUT THE ZAMBIA LAW DEVELOPMENT COMMISSION

The Zambia Law Development Commission, referred to as 'the ZLDC' or the 'Commission', is a semi-autonomous statutory body established under the Zambia Law Development Commission Act, Chapter 32 of the Laws of Zambia. The primary mandate of the Commission is law reform.

The functions of the Commission are to:

- Recommend the revision and reform of the law in Zambia;
- recommend the codification of unwritten laws in Zambia;
- review and consider proposals for law reform referred to the Commission by the Minister or the members of the public;
- holds seminars and conferences on legal issues;
- translate any piece of legislation into local languages; and
- research and make recommendations on
 1. the socio-political values of the Zambian people that should be incorporated into legislation;
 2. the anomalies that should be eliminated from the statute book;
 3. new and more effective methods of administration of the law and the dispensation of justice that should be adopted and legislated;
 4. the removal of archaic pieces of legislation from the statute book;
 5. new areas of the law that should be developed, which are responsive to the changing needs of the Zambian society.
- encourage international co-operation in the performance of its functions under this Act, and
- do all such things incidental or conducive to the attainment of the functions of the Commission.

COMPOSITION OF THE COMMISSION

The ZLDC is headed by a 13-member Commission composed of part-time members appointed by the Minister of Justice. The following are the members of the Commission:

PART I – PRELIMINARY PROVISIONS -MBALI 1 - ZOFUNIKA ZOYAMBIRIRA

1. Short Title - Mutu Waufupi

Legal Text

This Act may be cited as the Electoral Process (Amendment) Act, 2026, and shall be read as one with the Electoral Process Act, in this Act referred to as the principal Act.

Lamuloli silisintha lamulo lonse la Electoral Process Act. M'malo mwake, ilo likuwonjezera kapena kusintha mbali zinazake.

2. Amendment of Section 2 - Cikonzero ca Cigawo 2

Legal Text

Section 2 of the principal Act is amended by the—

(a) deletion of the definitions of “campaign period”, “candidate”, “Code” and “presiding officer” and the substitution therefor of the following:

“campaign period” means the period commencing after the close of nominations and ending on the day preceding an election, as the Commission determines, in accordance with section 28;

“candidate” has the meaning assigned to the word in the Constitution and includes a person on a party list for a seat under the proportional representation electoral system in the National Assembly or a council;

“Code” means the Electoral Code of Conduct set out in the First Schedule;

“presiding officer” means a person appointed as presiding officer by the Commission under section 37B; and

(b) insertion of the following new definitions in the appropriate places in alphabetical order:

“adoption certificate” means a certificate signed by the president and secretary-general of a political party, or in the absence of the secretary-general, the president and deputy secretary-general of a political party, as prescribed, specifying a candidate who is sponsored by that political party for an election to the office of President, Member of Parliament, mayor, council chairperson or councillor;

‘deputy secretary-general’ means an office-bearer designated as deputy secretary-general, or an equivalent office-bearer, of a political party in accordance with the Societies Act;

“nomination petition” means a nomination petition filed in accordance with section 95A;

“party list” means a list prepared by a political party for the purposes of the proportional representation electoral system and submitted to the Returning Officer or a district electoral officer by a political party in accordance with section 36C;

“person with disability” has the meaning assigned to the words in the Constitution;

“president” means an office-bearer designated as president of a political party in accordance with the Societies Act;

“secretary-general” means an office-bearer designated as secretary-general, or an equivalent office-bearer, of a political party in accordance with the Societies Act; and

“youth” has the meaning assigned to the word in the Constitution.

- **Nyengo ya kampeni** itanthauza nthawi imene imayamba pambuyo pa kulembetsa ndipo imatsekedwa patsiku lothera masankho asanacitike, monga mmene Commission lanenera pansi pa cigawo 28.
- **Munthu woma pa masankho** atanthauza—munthu amene akuimirira pa masankho a Prezidenti, Mpando wa Paliyamenti, kapena pa masankho Khansala a pansi pa dongosolo la munthu amene wapambana wonse; kapena munthu amene waphatikizidwa pa mndandanda wa cipani candale pa masankho a paliyamenti kapena local government pansi pa dongosolo la kuimira kolinganizidwa.

- **Ofisala Woimira Masankho** atanthauza munthu wosankhidwa ndi Commission pansi pa cigawo 37B kuti ayang'anire poponya mavoti pa malo ocitira masankho.
- **Setifiketi ya Kuvomerezedwa** litanthauza setifiketi losanidwa ndi prezidenti ndi mlembi wa cipani candale, pa cipepala colinganizidwa, cotsimikiza kuti cipani candale calipirira/cikucirikiza munthu woima pa masankho a Prezidenti, Membala wa Paliyamenti, Meya, Wakumpando wa Khonsolo, kapena Khansala.
- **Pempho la Kulembetsa** litanthauza pempho laperekedwa ndi kusungidwa kulingana ndi cigawo 95A.
- **Mndandanda wa Cipani** litanthauza mndandanda wokonzedwa ndi cipani candale kuti ugwiritsidwe nchito dongosolo la masankho a kuimira kolinganizidwa ndi kuperekedwa kwa Ofisala Wobweza Masankho kapena a district electoral officer molingana ndi cigawo 36C.
- **Munthu woperewera kucita zinthu zina [wolemala]** lili ndi tanthauzo limene laperekedwa mu Konstityusheni.
- **Prezidenti** litanthauza munthu wodziwika wa cipani candale pansi pa lamulo la Societies Act.
- **Mlembi [Kalembera]** atanthauza munthu wodziwika ngati mlembi kapena kalembera, kapena munthu wokhala ndi udindo wofanna nawo, mu cipani pansi pa Societies Act.
- **Mnyamata** lili ndi tanthauzo loperekedwa pa mawu mu Konstityusheni.

2. Amendment of Section 12 - Cikonzero ca Cigawo 12

Legal Text

Section 12(2) of the principal Act is amended by the insertion of the word “new” immediately after the words “registration of”.

Mawu Alamulo Osavuta Kumva

Kaperekedwe kameneka kasinthidwa mwakuwonjeza liwu “tsopano” pambuyo pa mawu “kalembetsedwe ka.”

Kodi Cimeneci Citanthauzanji?

Kumbuyoku, lamulo limalola bungwe la Commission kuletsa kulembetsa nthawi iliyonse pomwe masankho anali pafupi kucitika pofuna kukonzekera za masankho ndi kucita masankho. Pasi pa lamulo latsopano, pamene tsiku loponyera mavoti lalengezedwa, kulembetsa kwa masankho mu cigawo cimeneco kudzaimitsidwa kufikira cisankho cobwereza camalizidwa. Cimeneci citanthauza kuti anthu a mu cigawo ici sakwanitsa kulembetsa kukhala anthu oponya voti la cibwereza pa nthawi imeneyo, ngakhale kuti aloledwa kuponya mavoti kapena sanalembetse.

4. Amendment of Section 13 - Cikonzero ca Cigawo 13

Legal Text

Section 13 of the principal Act is amended by the insertion of the following new subsections immediately after subsection (2):

(3) The Commission may determine the period within which the Provisional Register of Voters may be inspected.

(4) A registered voter may inspect, electronically, the Provisional Register of Voters during the period determined by the Commission under subsection (3).

Mawu Alamulo Osavuta Kumva

Cigawo 13 casinthidwa mwakuwonjezera magawo ang'onoang'ono atsopano. Lamulo latsopano likunena kuti bungwe la Electoral Commission lingaganize za nyengo [nthawi] pomwe Cikalata Coyembekezera ca Oponya Voti (Provisional Register of Voters) cidzategulidwa kuti anthuwo acione. Kuwonjezera pamenepo, anthu omwe analembetsa kukaponya mavoti amaloledwa kupenya [kapena kuona] pa zolembedwa zomwe zili mu Provisional Register pa itnaneti [online] m'kati mwa nthawi yoikidwa ndi bungwe la Commission.

Kodi Cimeneci Citanthauzanji?

Cigawo 13 casintidwa mwakuwonjeza zigawo zina zatsopano. Zigawo zimenezo zinena kuti bungwe la Electoral Commission lingaganize za nthawi pomwe cikalata ca Provisional Register of Voters cidzatsegulidwa kuti anthu aonemo zomwe zinalembedwamo. Kuwonjezera pamenepo, anthu omwe analembetsa kudzavota amaloledwa kuona paokha mu cipepala ca Provisional Register pa intaneti [online] pa nthawi imene Commission yaika kucita zimenezi.

5. Amendment of Section 17(1) - Cikonzero ca Cigawo 17(1)

Legal Text

Section 17(1) of the principal Act is amended by the deletion of the word “ninety” and the substitution therefor of the word “fourteen”.

Mawu Alamulo Osavuta Kumva

Tsopano lamulo likunena kuti ngati munthu amene dzina lake mu cikalata ca Provisional Register of Voters ndipo dzina lake lalembedwa mosayenera, iyeyo ayenera kudziwitsa bungwe la Electoral Commission m'kati mwa masiku khumi ndi anai [14] m'malo mwa masiku makumi asanu ndi anai [90].

Kodi Cimeneci Citanthauzanji?

Kusintha kumeneku kukutanthauza kuti anthu oponya mavoti ali ndi nthawi yocepa kwambiri yocitira lipoti zolakwika pa “maina awo” pa cikalata ca Provisional Register of Voters ku Commission. M’malo mokhala masiku 90 [makumi asanu ndi anayi, anthu ovota tsopano ali cabe ndi masiku kghumi ndi anai [10] kuti anene za madandaulo awo kapena kukonza zolakwika. Cifukwa ca cimeneci, anthu ovota ayenera kukayang’ana mwamsanga pambuyo poti cikalatako cafalitsidwa ndi nkupereka lipoti la zolakwika zilizonse. Colinga ca kusintha kumeneku ndi kulumizitsa kalembetsedwe ndi kutsimikiza kacitidwe kameneka kotero kuti bungwe la Electoral Commission lingamalize nchito ya cipepala ca *voters’ register* m’nthawi yoyenera masankho asanacitike.

6. Amendment of Section 27 - Cikonzero ca Cigawo 27

Original Provision

Section 27(1) of the principal Act is amended by the deletion of the word “section 20” and the substitution therefor of the word “section 24”.

Mawu Alamulo Osavuta Kumva

Lamulo likusintha umboni wacigawo kucokera pa Cigawo 20 kukafika ku Cigawo 24.

Kodi Cimeneci Citanthauzanji?

Cimeneci ndi kukonza komwe kumacitika potsimikiza kuti mfundo za lamulo zili m’cigawo coyenera.

7. Amendement of Section 28 - Cikonzero ca Cigawo 28

Mawu Alamulo Osavuta Kumva

Nthawi zoikidwa za masankho ndi kusintha kocitidwa ziyenera kufalitsidwa mu Government Gazette ndi mu manyuzipepala kapena m’zipangizo zazithunzi zosankhidwa ndi Electoral Commission.

Kodi Cimeneci Citanthauzanji?

Lamulo limafuna kuti Commission likonzekere ndondomeko ya nthawi ya masankho lisanafike tsiku loponya masankho. Ndondomeko imeneyi likuphatikizapo zinthu zofunika ndi zocitika ngati tsiku lotsekera kulembetsa masankho, kuyang’ana mu buku la maina a anthu ovota, masiku a kulembetsa, masiku a kampeni, ndi tsiku la cisankho ndi maola oponya cisankho. Ndondomeko imeneyi imafalitsidwa mu Government Gazettee.

Lamulo limalolanso kuti Commission lisinthe ndondomeko kulikonse monga mmene kungakhalire kuti masankhowo akhale omasuka ndi oyenera kapena komwe tsiku loponya masankho lasinthidwa.

Kusintha kwatsopano kukufuna kuti bungwe la Commission lifalitse ndi kukonza ndondomeko mu Government Gazettee ndi mu manyuzipepala omwe amalitsidwa kwambiri m'dziko lonse kapena kupyolera mu zipangizo zazithunzi zosankhidwa ndi Commission.

Cimeneci citanthauza kuti uthenga wa masankho tsopano ukugawidwa pa mitundu yambiri yofalitsira, kukhala kosavuta kuti anthu onse apeze masiku ofunika kwambiri a masankho ndi zilengezo, pomwe nthawi ikadaliko.

8. Amendment of Section 30 - Cikonzero ca Cigawo 30

Mawu Alamulo Osavuta Kumva

Kaperekedwe kameneka kasinthidwa pofuna kudziwitsa zofunikira zatsopano kwa anthu olipiridwa poimirira pa masankho a cipani candale. Anthu amenewa oimirira pa masankho tsopano ayenera kutumiza setifiketi ya kusintha kwa civomerezo cocokera ku cipani cawo candale kukhala zipepala za mbali yawo yolembetsera. Cifukwa ca ciwonjezero cimeneci, ndime zomwe zili mu lamulo limeneli zalinganizidwa ndi kuikidwa manambala.

Kusintha kumafunanso kuti bungwe la Electoral Commission lifalitse mfundo za anthu olembedwa mu Government Gazettee kudzaima pa masankho, mu nyuzipepala yofalitsidwa m'dziko kapena kupyolera mu zipangizo za zithunzi zosankhidwa ndi bungwe la Electoral Commission. Kuwonjezera pamenepa, cifukwa ca lamulo latsopano lomwe laikidwamo, manambala a malamulo omwe alipo asintha, pomwe malamulo akale [2] ndi [3] tsopan akhala [3] ndi [4].

Kodi Cimeneci Citanthauzanji?

Kumbuyoku, muntu wofuna kuimirira pa masankho ngati Prezidenti kapena Vaisi Prezidenti amafunika kutumiza mapepala olembetsera masankho, ndalama za masankho kusiyo kokha Vaisi Prezidenti, kudziwitsa anthu za katundu yemwe ali naye ndi ngongole zake, kusaina afidaviti yowonetsa kuti munthuyo anali woyeneretsedwa kuimirira pa masankho, ndi cicirikizo cocokera kwa anthu dzana limodzi (100) olembetsedwa kukaponya voti wocokera ku Dera lililonse. Kusintha uku kumafuna kuti munthu wolipiridwa ndi cipani candale kuimirira pa masankho kuti atumize setifiketi yake yomuyenereza, kukhala umboni wakuti cipani camusankhadi kuti ndi munthu wawo woimirira pa cisankho.

Lamuloli limafunanso kuti bungwe la Electoral Commission lifalitse maina ndi mfundo za anthu olembetsedwa ndipo lifalitse zimenezi mu Gazette, manyuzipepala, kapena mu zipangizo za zithunzi. Kusintha kumeneku kumacititsa kuti dongosolo lamasankho likhale loyera kwambiri ndipo

lolongosoka cifukwa setifiketi yoyenereza imathandiza kucinjiriza mikangano m'kati mwa zipani zandale pa anthu olembetsedwa, pomwe kufalitsidwa kwa uthengawu kumakweza kuona mtima ndi cidaliro ca anthu onse pa kacitidwe ka masankho.

9. Amendment of Section 31- Cikonzero ca Cigawo 31

Mawu Alamulo Osavuta Kumva

Lamulo ili lasintidwa mwakuwonjezerako kamvedwe katsopano konena kuti pepala lolembetsera masankho ndi afidaviti ziyenera kutumizidwa pamodzi ndi setifiketi yoyenereza kwa munthu yemwe walipiridwa ndi zipani zandale, ngakhale kuti olembetsa masankho odziimira safunikira kupereka ciliconse. Kusintha uku kumafunanso kuti bungwe la Electoral Commission lifalitse mfundo za anthu onse olembetsedwa movomerezeka kumadera olembetsera.

Kodi Cimeneci Citanthauzanji?

Kumbuyoku, lamulo ili limangofuna munthu kulembetsa kukaimirira pa masankho kupitira mu cipani candale kuti atumizenso setifiketi yacivomerezo kukhala umboni kuti cipani camusankha ndi kumusainira kuti aimirire m'malo mwa cipani cawo, pomwe anthu odziimira safunikira kukhala ndi setifiketi yacivomerezo cifukwa iwosakuimira cipani candale ciliconse ndipo akuimirira paokha, ndipo lamulo ili limafunanso kuti bungwe la Electoral Commission kulengeza kwa anthu onse zamfundo zonse zololedwa ndi anthu olembetsawo kumadera awo pofuna kukweza kuona mtima ndi kulola anthu onse kudziwa yemwe wavomerezedwa kuimirira pa masankho.

Cikonzero cimeneci cikupanga dongosolo lolembetsa kukhala lowona ndi lopereka cifukwa cake ndi kutsimikiza kuti anthu a cipani candale ndi ovomerezedwa ndi zipani zawo asanatengemo mbali m'masankho, kuthandiza kucepetsa msokonezo ndi mikangano pa munthu weniweni ali woimirira pa cipani, pomweponso kulola anthu onse kuona mosavuta maina ndi mfundo za omwe akwanitsa bwino kulembetsa.

10. Replacement of Section 33 - Mlowammalo, Cigawo 33

Legal Text

The principal Act is amended by the repeal of section 33 and the substitution therefor of the following:

33. (1) Subject to subsection (2), a candidate for election in a district or ward of a council shall lodge with the returning officer for that district or ward of a council that candidate's nomination paper and an affidavit in the prescribed manner and form.

(2) A nomination paper and an affidavit referred to under subsection (1) shall be accompanied by an adoption certificate, except that this requirement shall not apply to an independent candidate.

(3) The nomination paper referred to under subsection (1) shall be subscribed, in the presence of the returning officer for that district by at least fifteen persons registered as voters in the district in which a candidate is contesting an election.

(4) The nomination paper referred to under subsection (1) shall be subscribed, in the presence of the returning officer for that ward of a council, by at least nine persons registered as voters in the ward in which a candidate is contesting an election.

(5) A person appearing before a returning officer for the purpose of subscribing a nomination paper in accordance with subsection (3) or (4) shall produce a voter's card and a national registration card to the returning officer for inspection as proof of identity.

(6) A person qualifies to be a mayor or council chairperson if, in addition to the requirements set out under Article 154(2) of the Constitution, that person has a certificate of clearance showing the payment of council taxes, where applicable.

(7) The Commission shall publish the particulars of validly nominated candidates at the nomination centres.

Mawu Alamulo Osavuta Kumva

Lamulo ili likulowa m'malo mwa Cigawo 33 ndipo limanena kuti munthu yemwe akuimirira ngati khansala, meya, kapena wakumpando ayenera kutumiza pepala lolembetsera ndi afidaviti kwa ofisala wobweza masankho mofunikira. Ngati munthuyo ndi wolipiridwa ndi cipani candale, kulembetsako kuyenera kuphatikizapo setifiketi yacivomerezo kucokera ku cipani cimeneco, koma anthu odziimira safunikira setifiketi imeneyi.

Pa masankho a cigawo [disitrikiti], pepala lolembetsera liyenera kucirikizidwa ndi anthu osacepera pa khumi ndi asanu [15] omwe ndi oponya voti olembetsedwa ocokera ku “wadi” limenelo. Pa masankho a cigawo [wadi], pepala lolembetsera liyenera kucirikizidwa ndi anthu osacepera pa khumi ndi asanu [9] omwe ndi oponya voti olembetsedwa ocokera ku “wadi” limenelo. Anthu ocirikiza ayenera kuonetsa khadi lolembetsera kuponya voti ndi NRC, kukhala umboni wotsimikizika.

Lamulo ili likunenanso kuti munthu yemwe akuimirira ngati meya kapena wakumpando wa khansala ayenera kukhala ndi setifiketi ya msonkho ya “council tax clearance certificate” ngati kungafunike. Kuwonjezera pamenepo, bungwe la Electoral Commission liyenera kufalitsa mfundo zonse za anthu amene ayeneretsedwa kuimirira, ku malo awo olembetsera.

Kodi Cimeneci Citanthauzanji?

Pansi pa lamulo lakale, mapepala olembetsera a masankho ku “wadi” amangofunika cicirikizo ca munthu olingalira, ndi womuthandiza, pamodzinso anthu olembetsedwa kukaponya mavoti ocokera ku wadi imeneyo. Lamulo latsopano lawonjezera nambala ya anthu ocirikiza [masapotazi] ofunikira. Pa masankho a cigawo [disitrikiti], pepala lombetsera tsopano nalonso liyenera kukhala locirikizidwa, pamaso pa ofisala wobweza masankho, ndi anthu osacepera pa anthu khumi ndi asanu [15] olembetsedwa wocokera kucigawo, pomwe pa masankho a wadi, ayenera kucirikizidwa ndi anthu osacepera pa anthu asanu ndi anai [9] olembetsedwa ocokera ku wadi. Anthu ocirikiza ayeneranso kuonetsa khadi lovotera ndi khadi la NRC, kukhala umboni wacizindikiro. Anthu olipiridwa ndizipani zandale ayeneranso kutumiza setifiketi ya civomerezo kucokera ku cipasi cawo, pomwe anthu odzimiira safunikira kukhal ndi setifiketi imeneyi cifukwa ndi osalipiridwa ndi cipasi candale.

Lamulo lakalele limafuna kuti munthu woimirira pa masankho ngati meya kapena wakumpando wa khonsolo akhale ndi setifiketi ya msonkho wakhonsolo wa tax clearance certificate ngati kungafunike, ndipo cimeneci capitiriza kukhala tere pansi pa lamulo latsopano. Komabe, lamulo latsopano limeneli lawonjezapo cinthu cina cofunikira ca Electoral Commission kuti lifalitse mfundo za anthu onse omwe analembetsa bwino m'malo awo olembetsera.

11. Insertion of Part IVA- Ciwonjezo ca Mbali IVA

Legal Text

The principal Act is amended by the insertion of the following new Part VIA immediately after Part IV called Proportional Representation system.

Cimeneci citanthauza kuti lamulo lakale lasinthidwa mwakuwonjezera Mbali yatsopano VIA, pambuyo pa Mbali IV. Mbali imeneyi yatsopano ili ndi malamulo aang'ono okhudzana ndi dongosolo la Kuimiridwa Kolinganiza, limene ndi dongosolo la electoral commission mmene muli mipandoya zipani yoperekedwa ku zipani zandale kulingana ndi kuculuka kwa mavoti omwe iwo adzalandira pa masankho.

Konstityusheni ladziwitsa dongosolo la nambala yophatikizidwa pa masankho. Cimeneci citanthauza kuti mipando ina mu Paliyamenti ndi makhonsolo adzapitiriza kudzadzidwa kupyolera mu dongosolo la munthu wopambana onse pa masankho, pomwe, pomwe mipando yowonjezera azimayi, anyamata ndi anthu operewera kucita bwino zinthu zina.

Pansi pa dongosolo la wopambana ndi wopeza masankho masankho oculuka koposa anthu ena omwe anaimrira naye mu konsitichuwensi kapena mu “wadi”. Dongosolo ili likadali cimodzimodzi pa masankho a mu makonsitichuwensi a Mamembala a Paliyamenti, meya, makhansala akumpando, ndi makhansala okhala m'mawadi.

Dongosolo latsopano la kuimira kolinganiza ndi losiyana cifukwa anthu sadzaponya mavoti awo mwacindunji a aliyense payekha kuti adzde mipando yotsalira. M'malo mwake, zipani zandale zidzatumiza mndandanda wokhala ndi maina a azimayi, anyamata ndi anthu operewera kucita zinthu zina. Pambuyo pa masankho, bungwe la Electoral Commission lidzagawa mipando yosungidwa pakati pa zipani zandale kulingana ndi nambala ya mavoti.

PART IVA PROPORTIONAL REPRESENTATION ELECTORAL SYSTEM

12. Section 36A – Eligibility for participation in proportional representation electoral system -

Legal Text

A political party that intends to contest for a seat under the proportional representation electoral system specified under Article 47(2)(b) and (3)(c) of the Constitution and in accordance with this Part shall have a candidate contesting for election as President.

13.Section 36B – Formula and distribution of seats under proportional representation electoral system

Legal Text

(1) The formula to be used by the Commission in the distribution of seats under the proportional representation electoral system is specified in the Second Schedule.

(2) The Commission shall, within seven days of the swearing in of the President-elect, distribute the seats under the proportional representation electoral system in the National Assembly and council, in proportion to the total number of valid votes received by a presidential candidate in the initial ballot.

(3) The Commission shall, where a political party refuses to take up a seat that has been distributed to that political party, re-distribute the vacant seat to a political party that qualified for a seat in line with the formula for distribution of seats referred to under subsection (1).

(4) The votes obtained by a presidential candidate of a political party that refuses to take up a seat under subsection (3), shall not be considered in the distribution of seats in accordance with this section.

Ili, ililonse lamulo latsopano lomwe lithanthauza kuti pambuyooa cisankho, bungwe la Electoral Commission Liyenera mwamsanga (m'kati mwa masiku asanu ndi awiri (7) kulumbiritsa Prezidenti) kugawa mipando ya kuimira kolinganizidwa mu Palyamenti ndi makhonsolo pogwiritisa nchito kacitidwe kolingana ndi kuculuka kwa mavoti omwe Prezidenti wacipani candale analandira m'masankho oyambirira. Zipani zomwe zili ndi mavoti oculuka cipezanso mipando yambiri ya kuimira kolinganiza.

14. Section 36C – Submission of party list

Legal Text

(1) A political party shall, within seven days after the distribution of the seats in accordance with section 36B, submit a party list to the Commission in a prescribed manner and form on payment of a prescribed fee.

(2) A party list submitted under subsection (1) shall be signed by the president or secretary-general of a political party.

(3) A party list shall be submitted, in the case of a seat in —

(a) the National Assembly, to the Returning Officer; and (b) a council, to a district electoral officer.

(4) A political party shall not include, on a party list, a candidate who contested a seat under the first-past-the-post electoral system.

(5) A party list submitted under subsection (1) shall be accompanied by a consent form for each candidate, as prescribed, signed by the candidate appearing on the party list.

(6) The Commission shall, where a candidate on a party list submitted to the Commission dies, resigns from the political party that sponsored the candidate or is expelled from the political party before the publication of the names of Members of Parliament and councillors under the proportional representation electoral system, request the political party to submit an additional party list within a period determined by the Commission.

(7) The Commission shall publish the party list in accordance with section 36G as follows:

(a) in the case of a Member of Parliament, where a candidate on a party list submitted under subsection (1) meets the requirements specified under Article 70 of the Constitution; and

(b) in the case of a councillor, where a candidate on a party list submitted under subsection (1) meets the requirements specified under Article 153(4) of the Constitution.

(8) The Commission shall notify the political party to take remedial measures to rectify the party list within a period that the Commission may determine where —

(a) in the case of a Member of Parliament, a candidate on a party list submitted under subsection (1) does not meet the requirements specified under Article 70 of the Constitution; and

(b) in the case of a councillor, where a candidate on a party list submitted under subsection (1) does not meet the requirements specified under Article 153(4) of the Constitution.

(9) The Commission shall, where a political party does not submit a party list within a period specified under this section, re-distribute the vacant seat to a political party that qualified for a seat in line with the formula for distribution of seats under section 36B.

(10) The votes obtained by a presidential candidate of a political party that does not submit a party list under subsection (9), shall not be considered in the distribution of seats.

Ngati munthu woima pa masankho wafa, watula udindo kucoka mu cipani, kapena watulutsidwa pomwe maina asafalitsidwe, bungwe la Commission lingapemphe cipani kuti citumize mndandanda wina kuladakali nthawi imene cipanico cayika.

Bungwe la Commission lidzafalitsa mndandanda wa cipani pokhapo ngati anthu oima pa masankho ali ndi zofunukura za lamulo la mpando wa Paliyamenti kapena khonsolo.

Ngati munthu woima pa masankho sakukwanitsa zofunikira bungwe la Commission Lidzauza cipani kuti cikonze mndandandao m’kati mwa nthawi yoikidwa, ndipo ngatio cipawi cilephera kutumiza mndandanda wake pa nthawi yoyenera, mpando wopanda munthu udzapatsidwa ku cipani cina cimene cinayenerezedwa pansi pa kacitidwe ka kagawidwe ka mipando. Kuwonjezera pamenepa, ngati cipani cilephera kutumiza mndandanda wake, mavoti ake munthu woimiriria ngati prezidenti anapeza sadzawerengedwa psgawa mipando.

Ili ndi lamulo latsopano lodziwitsidwa ndi kukonzedwa kocirikiza dongosolo la masankho a kuimira kolinganizidwa. Lamulo lakale linalibe malamulo ang’ono onena za mndandanda wa cipani cifukwa kunalibe mipando ya kuimira kolinganizidwa.

Mndandanda wacipani utanthauza mndandanda wokonzedwa ndi cipani kuti ugwiritsidwe nchito pa dongosolo la kuimira kolinganizidwa ndipo umatumizidwa kwa Wobweza Masankho [Returning Officer].

Lamulo latsopano likupereka dongosolo ku zipani zandale kuti zilondole pomwe zikutumiza mndandanda wacipani pa mipando yosungidwa pansi pa dongosolo

la kuimira kolinganizidwa. Lamulo ili likulongosola amene ayenera kusaina pa mndandanda wacipani, komwe uyenera kutumizidwa, m’kati mwa nthawi imene unafunika kuikidwa mu faelo, ndipo zofunikra za anthu oima pa masankho zoyenera kucita. Likulongosolanso comwe cimateka ngati mutu woima pa masankho wafa, wasiya cipani candale, kapena ngati kuti cipani calephera kutumiza mndandanda pa nthawi yoyenera.

15. Section 36D – Requirements of party list for seat in National Assembly

Legal Text

(1) A political party that submits a party list in accordance with section 36C for a seat in the National Assembly shall submit a party list for each category as follows:

(a) the number of women seats obtained by a political party;

(b) the number of youth seats obtained by a political party; and

(c) the number of persons with disabilities seats obtained by a political party.

(2) A party list submitted under subsection (1)(b) shall contain candidates that are youths for the entire duration of the term of Parliament.

(3) A party list submitted under subsection (1)(c) shall —

(a) contain alternates of the classes of disabilities; and

(b) have candidates in possession of a certificate of registration issued in accordance with the Persons with Disabilities Act.

M'malo mwake, iwo ayenera kukonza mndandanda wacipani wa gulu lililonse, la azimayi, la anyamata, ndi la anthu operewera kucita zinthu zina. Bungwe la Electoral Commission pambuyo pake lidzagwiritsa nchito mindandanda imeneyi kudziwa kuti ndani ayenera kukhala m'mipando imeneyo.

16. Section 36E – Number of councillors under proportional representation electoral system -

Legal Text

(1) The number of councillors under the proportional representation electoral system in a council shall be calculated based on the eighteen percent of the proportional representation seats against constituency based seats in the National Assembly.

(2) The number of seats under the proportional representation electoral system in a council shall be distributed among women, youth and persons with disabilities using the ratio four to three to one, respectively, except that each category of women, youth and persons with disabilities shall have at least one seat.

(3) Despite subsections (1) and (2), a council shall, where the proportional representation seats in a council is less than three in accordance with the calculation referred to under subsection (1), consist of three proportional representation seats comprising of one seat for women, youth and persons with disabilities, respectively.

(4) The Commission shall publish the number of proportional representation seats in each council in accordance with this section, as prescribed

17. Section 36F – Requirements of party list for seat in council

Legal Text

(1) Subject to section 36E, a political party that submits a party list in accordance with section 36C for a seat in a council shall submit a party list for each category as follows:

- (a) the number of women seats obtained by a political party;*
- (b) the number of youth seats obtained by a political party; and*
- (c) the number of persons with disabilities seats obtained by a political party.*

(2) A party list submitted under subsection (1), in relation to youths, shall have candidates that are youths for the entire duration of the term of a council.

(3) A party list submitted under subsection (1) in relation to persons with disabilities shall—

- (a) contain alternates of the classes of disabilities; and*

(b) have candidates in possession of a certificate of registration issued in accordance with the Persons with Disabilities Act.

18. Section 36G – Publication of party list

Legal Text

The Commission shall, within seven days of the receipt of a party list in accordance with section 36C, process and publish the names of Members of Parliament and councillors that obtained a seat under the proportional representation electoral system in the Gazette, and a newspaper of general circulation in the Republic or any electronic media that the Commission may determine.

19. Section 36H – Vacancy in office of Member of Parliament under proportional representation electoral system

Legal Text

(1) Article 72(1) and (2)(a), (b), (c), (d), (e), (f), (h) and (i) of the Constitution shall apply in relation to a vacancy of a Member of Parliament under the proportional representation electoral system.

(2) In addition to the grounds specified under subsection (1), a political party that sponsored a Member of Parliament holding a seat under the proportional representation electoral system may recall the Member of Parliament at any time during the term of Parliament.

(3) A person who causes a vacancy in the National Assembly due to the reasons specified under Article 72(2)(a), (b), (c), (d) and (h) of the Constitution shall not, during the term of that Parliament —

(a) be eligible to contest an election or qualify to be on a list under the proportional representation electoral system; or

(b) hold public office.

(4) The Speaker shall, where a vacancy occurs in the National Assembly for a seat under the proportional representation electoral system, inform the Commission of the vacancy, in writing, within seven days of the occurrence of the vacancy.

(5) The Commission shall, within ninety days of the vacancy in accordance with subsection (1) or (3), fill the vacancy with the next available candidate on a party list of a political party that holds the seat.

(6) The Commission shall, where a party list of a political party has no remaining candidate during the term of Parliament, request the political party to submit an additional party list within thirty days of the request.

(7) Sections 36C and 36D shall apply to an additional party list referred to under subsection (6).

(8) The Commission shall, where a political party fails to submit an additional party list within the period specified under subsection (6), re-allocate the vacant seat to a political party that qualified for a seat in accordance with the formula for distribution under section 36B.

(9) The votes obtained by a presidential candidate of a political party that fails to submit an additional party list under subsection (8) shall not be considered in the distribution of seats.

(10) A Member of Parliament holding a seat for a political party under the proportional representation electoral system shall, where a political party is dissolved, cease to be a Member of Parliament and the seat shall be re-allocated to a political party that qualifies for a seat in line with the formula for distribution of seats under section 36B.

(11) A vacancy occurring in accordance with this section within one hundred and eighty days preceding a general election shall not be filled.

Zifukwa zimenezo zimaphatikizapo kutula udindo, kusayenerezedwa, khalidwe loipa, kusiya kapena kucotsedwa mu cipani comulipirira munthu, kuleka kukhala nzika, kusayenerezedwa ndi bwalo la Konsitityushono khoti, ndi imfa. Zotsatira zake ndi zakuti Membala wa Paliyamenti osankhidwa kupitira mu Kuimira Kolinganizidwa samacitiridwa ngati kuti iye ndi wacikhalire cifukwa cakuti iye analowa mu Paliyamenti kupitira mu mndandanda wacipani.

Caciwiri, mbali ya cigawo (2) imawonjezera lamulo lina lomwe ndi lacindunji pa kuimira kolinganiza: cipani candale comwe cinalipirira MP cingaitane MP ameneyo pa nthawi iliyonse pomwe Paliyamenti ikugwira nchito. M'mawu osavuta, cipani cingacotse Mamembala ake a Paliyamenti osankhidwa kupitira mu Kuimira Kolinganizidwa ngakhale kuti palibe zifukwa zenizeni za lamulo zomwe zacitika. Cimeneci cikupatsa cipani mphamvu zazikulu pa anthu ake osankhidwa m'mipando kupitira mu Kuimira Kolinganizidwa mosiyana ndi masankho a mipando ya konsitityuwensi.

Cacitatu, mbali ya Cigawo (3) imanena kuti ngati munthi wacititsa kuti pakhale mpandp wopanda mwini cifukwa ca zifukwa zolembedwa munthu ameneyo ayenera kulangidwa pa nthawi yomwe Paliyamenti ikuletsedwa kupikisana pa cisankho kapena kukhala pa m'ndanda wa kuimira kolinganiza, ndipo kumwetsa kuti asakhale ndi ofesi yaikulu. Conco lamulo pano Likuyesa Kufooketsa anthu kusanula udindo, kusamukira kucipani cina, kucita zinthu zosiyana ndi malamulo, kapena mwinamwake kucititsa kuti pakhale mpando wopanda mwini ndipo pambuyo pake mofulimira kubwerera kundale.

Cacinai, mbali ya Cigawo (4) imafuna sipika kudziwitsa bungwe la Electoral Commission mwakulemba cidizwitso m'kati mwa masiku asanu ndi awiri (7) pambuyo pokhala ndi mpando wa kuimira kolingawiza. Cimeneci citanthauza kucita lipoti sitepe imene imayamba ndi dongosolo loikapo wina.

Cacisanu, mbali ya Cigawo (5) imanena kuti bungwe la Commission liyenera, kudza mpando wopanda mwini m'kati mwa masiku makumi asanu ndi anai (90) pogwiritsa nchito munthu wotsatira pa masankho pa cipani candale cimodzimodiz cimene cili pa m'ndandanda wa cipani. M'mawu osavuta kumwa, munthu wotsatira pamezere wa m'ndandanda wacipani akwera kuti

atenge mpando umenewo. Cimeneci ndiyo mfundo yaikulu ya kulowedwa m'malo kwa mipando ya.

Cacisanu ndi cimodzi, mbali ya Cigawo (6) cikucuta zinthu ndi za mndandanda wacipani womwe ulibe anthu aynenera kuimirira pa masankho. Ngati palibe aliyense wotsala pa mndandanda, bungwe la Commission liyenera kupempha cipani kuti citumize mndandanda wina owonjezera m'kati mwa masiku makumi atatu (30). Cigawo cacisanu ndi ciwiri (7) cimanena za malamulo a ziyenerezo ndi mndandanda wa zofunikira zomwe zingagwire nchito to mndandanda wa zofumikira zomwe zingagwire nchito to mndandanda umenewo.

Cacisanu ndi citalu, mbali ya Cigawo (8) bimanena kuti ngati cipani sicitumiza mndandanda wina kukadali nthawi, mpando umenewo sukhala wopanda munthu kwa nthawi yaitali. M'malomwake, bungwe la Commission limapereka mpando uja ku cipani cina candale amene anayenerezedwa pansi pa kacitidwe kogawa mipando. Mbali ya Cigawo (9) cimawonjezera pansi pa mbali ya cigawo (9) cimawonjezera kuti mavoti a cipani comwe munthu wawo woima ngati prezidenti sadzawerengedwa pogawanso. Colinga cake ceniceni ndi kuletsa cipani kupeza phindu kucokera pa dongosolo ili pomwe akukana kutsatira malamulo a mndandanda.

Cacisanu ndi citatu, mbali ya (10) imanena kuti ngati cipani candale cathetsedwa, kacitidwe ka kuimira kolinganizidwa ka Mamembala a Paliyamenti kokhudzidwa ameneo sakhalanso Membala wa Paliyamenti, ndipo mpando umaperekedwa ku cipani cina comwe uyeneredwa pansi pa kacitidwe kameneka. Cimeneci citanthauza kuti mpanfo umwenewo udzakhala wa kapangidwe ka cipani, osati kukhala mpando wa MP payekha.

Potsirizira, mbali ya Cigawo (11) imanena kuti ngati mpando wopanda mwini wapezeka m'kati mwa masiku 180 masankho a dziko asanacitike, mpando umenewo sudzalowedwa m'malo. Codziwika apa ndi copewa kusankha wolowa m'malo kwa nyengo yocepa yotsala pomwe Paliyamenti isatsekedwe.

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuti kacitidwe ka kuimira kolinganizidwa ka MP ndi kogwirizana kwambiri ku zipani zawo zandale. Iwo angacoke pa mipando yawo mosavuta kusiyana ndi mmene ma MP a Konsitichuwensi angacitire ndipo cipani cili ndi mphamvu zowaitamanso, kuwalora m'malo, kapena kutaya mpando umenenwo ngati cipani cilepera kutsatira malamulo a mndandanda. Cimeneci cimalimbitsa mwambo wa cipani ndipo cimasunga dongosolo la Kuimira Kolinganizidwa kukupenya pa zocita ndi mindandanda ya cipani kuposa pa munthu payekha. Pa nthawi imodzimodzi, cimacepetsa ma MP kukhala womasuka pa Kuimira Kolinganizidwa cifukwa kukhala kwawo mu Paliyamenti kumadalira kwambiri pa cipani.

Caciwiri, Paliyamenti ndi yotetezedwa kucokera ku mipando yosakhala ndi anthu kwa nthawi yaitali ndi masankho acibwereza a mipando ya Kuimira

Kolanganizidwa, cifukwa mpando wopanda mwini umapatsidwa kwa winawake kucokera ku cipani m'malo mokhala ndi masankho acibwereza. Cimeneco cimagwiritsa nchito dongosolo ili kukhala lofulumira kwambiri ndiponso lotheke kwambiri, ngakhale kuti kuti cimeneci cimatanthauzanso kuti anthu akuimiridwa kupitira mu mndandanda wa cipani kuposa ndi kusankha mwacindunji poikapo mlowam'malo. Lamulo lakuti palibe kudzadza pomwe Paliyamenti ili pafupi kutsekedwa limapereka ganizo lofuna kusunga nthawi ndi zinthu zofunikira pomwe mpando ukhala wopanda mwini mosedwa kwambiri kumapeto a nyengo ya paliyamenti.

Cimeneci citanthauza kuti mipando yoperekedwa ku zipani zandale pansi pa dongosolo la kuimira kolanganizidwa kumakhala kwa cipani candale ndipo osati kwa Membala wa Paliyamenti payekha.

Ngati Membala wa Paliyamenti wasiya ofesi, wafa, watula udindo, kusayenerezedwa, kapena wacotsedwa ndi cipani candale, mpando umenewo sumakhala wopanda munthu kwa nthawi yaitali. Bungwe la Electoral Commission liyenera kuiapo munthuyo ndi wina yemwe ali pa mndandanda kotero kuti cipani candale cipitiriza kusunga mpando womwe cinapambana pa nthawi ya masankho.

Lamulo limalimbikitsanso zipani zandale kuti zizikhala ndi anthu owalowa ali okonzeka. Ngati cipani cilephera kupereka maina pomwe akufunika, cipani cimeneco cingalandidwe mpando umenewo ku cipani cina candale comwe cayenerezedwa.

Kuwonjezera pamenepa, Mamembala a Paliyamenti amene alephera pa mipando yawo cifukwa colakwitsa malamulo kwakukulu sangabwerere ku Paliyamenti kapena kukhala ndi ofesi lalikulu pa nthawi ya utali wa paliyamenti.

Lamulo ili limanenanso kuti ngati cipani candale cathetsedwa, mipando yawo ya kuimira kolanganizidwa imatengedwa ndi kugawidwa pakati pa zipani zina zoyenerezedwa. Komabe, ngati mpando wopanda mwini wakhalapo pomwe masankho dziko [general elections] ali pafupi, mpando umenewo udzangokhala wopanda munthu kufikira pomwe dziko liponyanso masankho.

20. Section 36I – Vacancy for councillors in proportional representation electoral system

Legal Text

(1) Article 157 (1) and (2)(b), (c), (e), (f) and (g) of the Constitution shall apply in relation to a vacancy of a councillor under the proportional representation electoral system.

(2) In addition to the grounds specified under subsection (1), a political party that sponsored a councillor holding a seat under the proportional representation electoral system may recall the councillor at any time during the term of a council.

(3) Where a vacancy occurs in the office of a councillor, the —

(a) Town Clerk or Council Secretary of the local authority shall, within seven days of the occurrence of the vacancy, inform the Commission, in writing, of the vacancy; and

(b) Commission shall, within ninety days of the vacancy, fill a vacancy with the next available candidate on a party list of a political party that holds the seat.

(4) The Commission shall, where a party list of a political party has no remaining candidates during the term of a council, request the political party to submit an additional party list within thirty days of the request.

(5) Sections 36C and 36F shall apply to an additional party list referred to under subsection (4).

(6) The Commission shall, where a political party fails to submit an additional party list within the period specified under subsection (4), re-allocate the vacant seat to a political party that qualified for a seat in accordance with the formula for distribution under section 36B.

7) The votes obtained by a presidential candidate of a political party that fails to submit an additional party list under subsection (6) shall not be considered in the distribution of seats.

(8) A councillor holding a seat for a political party under the proportional representation electoral system shall, where a political party is dissolved, cease to be a councillor and the seat shall be re-allocated to a political party that qualifies for a seat in line with the formula for distribution of seats under section 36B.

(9) A vacancy occurring in accordance with this section within one hundred and eighty days preceding a general election shall not be filled.

Pamene mpando wa khansala wopanda mwini [wopanda munthu], a Town Clerk kapena a Council Secretary ayenera kudziwitsa ungwe la Electoral Commission mwakulemba m'kati mwa masiku asanu ndi awiri [7]. Pambuyo polandira uthenga umenewu, bungwe la Electoral Commission liyenera kuikapo munthu

wina m’kati mwa masiku 90 mwakusankha wina amene alipo kucokera pa mndandanda wa cipani candale. Cimeneci cimatsimikiza kuti cipani candale cisunga mpando womwe cinapeza poyamba.

Ngati cipani candale cili ndi maina owonjezera otsala pa mndandanda wawo, bungwe la Electoral Commission lidzapempha cipani cimenco kuti citumize mndandanda wina m’kati mwa masiku makumi atatu [30]. Mndandanda watsopanowu uyenera kutsatira malamulo amodzimidzi omwe anagwiritsidwa nchito pa mndandanda woyamba.

Komabe, ngati kuti cipani candale calephera kutumiza mndandanda wina m’kati mwa nyengo yofunikira, mpando wopanda mwini udzaperekedwa ku cipani cina candale comwe ciyeneretsedwa panso pa dongosolo logwiritsidwa nchito pogawa mipando ya kuimira kolinganizidwa. Pa cocitika cimeneci, mavoti olandiridwa ndi anthu oima pa uprezidenti wa cipani candale comwe cinalephera kutumiza mndandanda sadzaganiziridwa pogawiranso mipando.

Lamulo ili limanenanso kuti ngati cipani candale cathetsedwa, khansala aliyense yemwe ali panso pa mpando wa kuimira kolinganizidwa amalandidwa mpando umenewo, ndipo mpandowo umagawidwira ku cipani candale coyenerezedwa.

Ngati mpando wopanda mwini ukucitika m’kati mwa masiku 180 masankho a dziko asanacitike, mpando umenewo sudzadzadzidwa cifukwa dziko likonzekera masankho atsopano.

Kodi Cimeneci Citanthauzanji?

Lamulo latsopano ili likutanthauza kuti pamene khansala wasankhidwa kupitira pa kuima kolinganizidwa, wasiya ofesi kapena walephera mpando wake, bungwe la Electoral Commission liyenera kudziwitsidwa m’kati mwa masiku asanu ndi awiri, ndipo mpando umenewo uyenera kudzadzidwa m’kati mwa masiku makumi asanu ndi anai [90] pogwiritsa nchito mndandanda wacipani candale kotero kuti mpando umenewo upitiriza kukhala wacipani cimeneco.

Cimeneci cithandiza kusunga makhonsolo kugwira nchito popanda kucedwa, kutsimikiza kuti zipani zandale kukhala ndi udindo wosunga mndandanda wawo wa anthu oima pa masankho kukhala wolembedwa bwino, ndi kumatsimikiza kuti mipando imakhala ndi cipani comwe cinapambana pa mavoti, kucinjiriza kutayika kosayenere kapena kusagwiritsa nchito mipando imeneyo.

PART VI – RETURNING OFFICERS AND PRESIDING OFFICERS

22. Repeal and Replacement of Section 37/Appointment of returning officer- Kucotsa Ndi Kuikapo Lamulo Lolowa M’malo 37

Legal Text

The principal Act is amended by the repeal of section 37 and the substitution therefor of the following:

37. The Commission shall appoint a returning officer, in respect of each constituency, district or ward, by notice in the Gazette.

Mawu Alamulo Osavuta Kumva

Mawu osavuta, lamulo likusinthika kucokera popenyetsa pa cisamaliro ca malo oponyera masankho pa konsitichuwensi, pa cigawo, ndi pa mlingo wa wadi. Lamulo latsopano likulolanso bungwe la Electoral Commission kuti liike anchito amenewa popanda kulindira tsiku la masankho kulengezedwa, limene lingacititse kukonzekera ndi kulumikizana pa masankho.

Cinthu cina cofunikira kusintha ndi kalembedwe ka nchito komwe kayenera kufalitsidwa mu Gazette. Cimeneci cimacititsa dongosolo kukhala lipamwamba ndiponso loyera cifukwa anthu onse ndi zipani zandale zingadziwe kuti ndani walembedwa nchito kuti asamalire dera la masankho.

Kodi Cimeneci Citanthauzanji?

Cikonzero cimeneci ciwonjezera kupatsa bungwe la Electoral Commission nthawi yaikulu ya masankho mwakulola nchito kucitika masiku a masankho asanalengezedwe. Komabe, cifukwa ca yobweza masankho, [*returning officer*] idzakhala ndi ulamuliro waukulu pa masankho m'madera awo, ndipo pangakhaleenso madandaulo a kusakondera kapena kusagwiritsa nchito bwino mphamvu ngati kusasamala sikupitirizidwa.

23. Insertion of Sections 37A and 37B

Legal Text

Powers and duties of returning officer

37A. (1) A returning officer shall be in charge of electoral activities at a constituency, district or ward.

(2) Despite the generality of subsection (1) a returning officer shall —

- (a) conduct the nomination process at constituency, district or ward level;*
- (b) collate results in a constituency, district or ward;*
- (c) declare National Assembly and local government election results;*
- (d) announce presidential results in a constituency; and*
- (e) perform any other election related duties as determined by the Commission and under this Act.*

Mawu Alamulo Osavuta Kumva

Munthu wobweza masankho kapena returning officer, ali ndi udindo wosamalira masankho mu konsitichuwensi, m'dera, kapena mu wadi. Iwo alinso ndi udindo wolengeza wopambana ku National Assembly ndi ku boma laling'ono [local government] pa masankho m'dera lawo, ndi kulengeza zotsatira za masankho a prezidenti ku konsitichuwensi. Kuwonjezera pamenepo, iwo amacita nchito zina za masankho zoperekedwa ndi bungwe la Electoral Commission. Mwacidule, munthu wobweza masankho amatsimikiza kuti zotsatira za masankho m'dera lawo zacitidwa bwino ndipo kuti dongosolo la zotsatira zake lalengezedwa.

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuti lamulo limanena za nchito ya returning officer, amene ali ndi udindo wosamlira masankho pa mlingo wa konsitichuwensi, pa mlingo wa dera ndi pa mlingo wa wadi. Cimeneci citanthauza kuti dongosolo la kulembetsa anthu, kuwerengera masankho, ndi kulengeza zotsatira za masankho akuyang'aniridwa ndi kugwirizanitsidwa ndi munthu waudindo m'dera lililonse.

Lamulo laling'ono ili likuthandiza kutsimikiza kuti masankho akucitidwa m'njira yolondola, yotheka ndi m'kacitidwe koyenera, ndiponso mwakucepetsa msokonezo, ndi kuwopsa kwa kusasunga bwino zotsatira za masankho. Cimatimikizanso kuti zotsatira za masankho zitengedwa moyenera, kutsimikizidwa, ndipo ndi kulengezedwa m'njira yoona mtima ndi yocilungamo.

Kuwonjezera pamenepa, lamulo ili likulimbikitsa kuwerengera, kuona mtima, ndicidaliro ca anthu onse pa dongosolo la masankho cifukwa pali munthu waudindo woyang'anira ndi kuwerengera pa zocitika za masankho m'dera lililonse. Kwenikweni, lamulo ili likukweza kacitidwe kosamalidwa ka masankho omasuka, osakondera, okhulupirika mwakupereka nchito ndi maudindo kwa a returning officer.

24. Appointment of Presiding Officer

37B. The Commission shall, after prescribing a date for an election, appoint a presiding officer for each polling station at which the election is conducted.

Mawu Alamulo Osavuta Kumva

Pambuyo pakuti bungwe la Electoral Commission lakonza tsiku la masankho, liyenera kusankha munthu woyang'anira masankho kapena *presiding officer*, pa malo aliwonse oponyera mavoti. Munthu ameneyu, ndi munthu yemwe ali ndi udindo woyang'anira ndi kusamalira zocitika za cisankho patsiku lamasankho.

Cimeneci citanthauza kuti malo aliwonse ocitira mavoti adzakhala ndi munthu wotsimikizika waudindo woyang'anira dongosolo la kuponya mavoti, motero kutsimikiza kuti masankho akucitidwa moyenera ndi kuyang'aniridwa kuyambira m'malo momwe anthu amakhala.

Pali kuwerengera kwabwino pa malo aliwonse ovotera cifukwa munthu woyang'anira, *presiding overseer*, ali ndi udindo wa kavotedwe, kusunga cilungamo, kuthandiza anthu ovota monga momwe kungafunikire, ndi kutsimikiza kuti mavoti akuponyedwa m'bokosi ndipo akuwerengeredwa kulingana ndi lamulo. PART VII – VOTING, COUNTING, AND RESULTS

25. Amendment of Section 60

Legal Text

Section 60 of the principal Act is amended by the deletion of subsection (6) and the substitution therefor of the following:

(6) A voter shall, once the voter has received a ballot paper referred to under subsection (5)

(a) enter an empty voting booth;

(b) mark the ballot paper in a way that indicates the candidate the voter intends to vote for;

(c) fold the ballot paper to conceal the voter's vote;

(d) cast the ballot paper in the ballot box; and

(e) without delay, leave the voting station

Mawu Alamulo Osavuta Kumva

Malamulo akale ndi atsopano onse akulongosola cimene munthu wovota ayenera kucita pambuyo palandira mapepala a mavoti pa malo ovotera. Kacitidwe kameneka m'malamulo onse ali pafupifupi ofanana, koma lamulo latsopano likucititsa mawu aang'ono ndi kapangidwe kake asintha kuti akhale atsopano ndi osavuta kulondola.

Pansi pa lamulo lakale, pambuyo polandira mapepala a mavoti ocongedwa ndi munthu woyang'anira, munthu wovota amalowa m'malo ngati kacipinda, mwacinsinsi *aconga pa munthu yemwe afuna kuvotera*, apeteka pepala lovotera kuti libise voti lake, kuliika mu baloti bokosi, ndipo ndi kucokapo nthhawi yomweyo pa malo ovotera.

Lamulo latsopano likusunga dongosolo limodzimodzi, koma lisintha mawu ena ndi kaembedwe ka ciganizo. M'malo monena kuti "voting zompartment", ilo tsopano ligwiritsa mawu akuti "voting booth." Mawu onse awiri atanthauza mawu acinsinsi komwe munthu angaponye voti mwacinsinsi. Lamulo latsopano likucotsanso mawu a kapandawini "yocongedwa pansi pa cigawo (5) (c)" ndiopo m'malo mwakungoti "pepala la ballot limene illi pansi pa cigawo (5)." Cimeneci cikulitsa ndi kumveteketsa bwino mawu kotero kuti angagwire nchito, ku baloti pepala lomwe limaperekedwa kwa munthu wovota.

Kusintha kwina ndi mawu onena za kusankha munthu wovotera. Lamulo lakale limanena kuti munthi wovotera ayenera kusonyeza munthu amene iye "afuna kumuvotera," pomwe lamulo latsopano limena kuti, "alingalira kumuvotera." Ngakhale kuti tanthauzo la mawu amenewo ndi lofanana, mawu atsopano ndi wolunjika ndipo ndi atsopano.

Kusintha kothera kwenikweni ndi nkhani ya umisiri. Mu lamulo lakale, ndime yothera inalembedwa "(f)" ngakhale kuti panalibe ndime "(e)", imene inali cabe kulakwitsa polemba. Lamulo latsopano lakonza pamenepa ndi kulemba ndime yothera kukhala ngati "(e)".

Kodi Cimeneci Citanthauzanji?

Kukonza kumeneku kukucititsa kalongosoledwa kukhala lolongosoka ndi losavuta kumvetsetsa mwakugwiritsa nchito cilankhulo copepuka pokenza zolakwika. Cimeneci cimacititsa kukhala kosavuta kumvetsa zinthu zokhudza lamulo ndi kuceptsa msokonezo kapena mikangano pa kalongosoledwe kovotera. Lamulo ili limalimbitsanso mfundo zofunikira za demokirase ngati cindindi ca voti, kuvota mwadongolo, ndi cisamaliro ca malo ovotera mwakufuna anthu ovota kucokapo pa malo ovotera pambuyo poponya voti. Zonsezi

zikucititsa kuti kusintha kumeneku kukonze mawu ndi kalembedwe ka lamulo popanda dongosolo lenileni lovota kapena ufulu wa anthu ovota.

26. Amendment of Section 68/ Lamulo Lokonzedwa 68

Legal Text

Section 68 of the principal Act is amended by the deletion of—

(a) the marginal note and the substitution therefore of the following:

Counting of votes and announcement of results; and

(b) subsection (3) and the substitution therefor of the following:

(3) A presiding officer shall mark “rejected” for a rejection on the back of each rejected ballot paper and file the rejected ballot paper separately.

Mawu Alamulo Osavuta Kumva

Lamulo ili likusintha Cigawo 68 mwakulembanso manotsi a pambali pa cigawo ndi kulongosola mmene mabaloti epa ayenera kusungidwira pa nthawi yovota.

Lamulo ili likunenanso kuti pamene mabaloti pepa akanidwa pa nthawi yowerengera mavoti, presiding officer ayenera kulemba liwu “okanidwa” kumbuyo kwa abaloti pepa ndi kulisunga pambali pa mabaloti pepa abwino. Cimeneci cimathandiza mosavuta kuzindikira mavoti okanidwa ndi kutsimikiza kuti kacitidwe kowerengera ndi kolondola, koona mtima ndipo kosavuta kutsimikiza.

Cikonzero ca mutu wa kusintha (zolembe za pambali) za cigawo cocokera pa “Kuwerengera mavoti ndi kulengeza za zotsatira zoyambirira” kukafika ku “Kuwerengera mavoti ndi cilengezo ca zotsatira,” cikucotsapo liwu “zoyambirira,” lomwe likucititsa kumveka kuti cigawo cimeneco cikucita ndi kuwerengera ndi kutsimikiza zotsatira za masankho. Kusintha kumeneku kukulowa m’malo kukanidwa kofunikira kuconganga kotero kuti m’malo moconganga, “A kukanidwa,” munthu woyang’anira ayenera kungoconganga kuti “okanidwa” kumbuyo kwake kwa baloti pepa ndipo liikidwe mu faelo palokha.

Lamulo lakale la pansi pa Cigawo 68 limafuna kuti munthu woyang’anira [presiding officer], pambuyo poponya mavoti, kutsegula mabokosi a mabaloti pepa, kusonkhanitsa mapepalawo kulinga ndi masankho aliwonse ocitidwa pa malo ovotera, kulinganiza mabaloti pepa ndi aja omwe anaperekedwa, kuwerengera mavoti a cisankho ciliconse, ndipo ndi kulengeza ndi kufalitsa zotsatirazo m’manambala ndi m’mawu pa malo oponyera voti.

Limanenanso kuti mabaloti pepa angakanidwe ngati munthu yemwe iwo anadziwa ngati wovota, anali ndi mavoti oculuka kuposa munthu winayo, mavoti osacongedwa, anacongedwa m’njira yomwe inapangitsa kuti munthu wakuti anthu amuvotere likhale losadziwika bwino, silinakhale ndi cizindikiro

codziwika, kapena kuti mabaloti pepa amenewo sanali mabaloti pepa oyenerezedwa ndipo ngati anacongedwa ndi lembo “A okanidwa” kusiyana ndi kulemba kumbuyo kwake “okanidwa.”

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuti dongosolo lowerengera mavoti pa malo oponyera mavoti limakhala pa nthawi imodzimodzi, pmwe mabaloti pepa asonkhanitsidwa, kuwerengedwa, ndipo zotsatira zake kulengezedwa ndipo mavoti osalongosoka akukanidwa ngati sakuoneka bwino, ndi osacongedwa kapena akusonyeza pamalo posankha pawiri.

Kuwonjezera pamenepo, lamulo ili lasinthidwa m’njira ziwiri, liwu “loyembekezera” lacotsedwa pa mutu [zolembe za pambali], lomwe licititsa kuti zotsatira kumveka pothera pomwe zilengezedwa pa malo oponyera voti. Cizindikiro cokanira casinthidwa kucokera pa “A wa kukanidwa” ndi kukhala cabe “kukanidwa,” ndi kupangitsa ilo kukhala lopepuka ndi losavuta kugwiritsa nchito. Lamulo ili likuthandiza kupanga dongosolo ili kukhal losavuta, lopepuka ndi lodziwika, ndi kucepetsa msokonezo wojambula zotsatira ndi mabaloti okanidwa.

27. Amendment of Section 70 - Lamulo Lokonzedwa 70

Lamulo latsopano ili lasintha mwakucotsa ndi kulowedwa m’malo ndi zolembe za pambali za manotsi Cigawo 70 cocokera pa “zotsutsa zokhudzana ndi kuwerengera kwa mavoti ndi cilengezo ca zotsatira zoyembekezera,” kukafika pa “Zotsutsa zokhudzana ndi kuwerengera kwa mavoti ndi cilengezo ca zotsatira za masankho.”			

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuti lamulo ili likulongosola za ganizo lake. Kumbuyoku, mawu a mtsinde onenedwa, anali kutanthauza kuti zotsutsa zingangokhudzana ndi dongosolo la kawerengeredwe ndi kulengeza zotsatira zoyembekezera. Mbali imene inakonzedwa ya zolembe za pambali, tsopano ikucotsapo kuiika malire komwe kunalipo kocitidwa ndi liwu “zoyembekezera” ndipo limacititsa kuti zimenezi zikhale zotsatira zoyenera. 28. Amendment of Section 71-Lamulo Lokonzedwa 71

Lamulo ili lasinthidwa mwakucotsa zolembedwa za pambali zomwe zimanena kuti “Kalongosoledwe kokhudza zotsatira zoyembekezera ndi zinthu zovotera,” ndipo lalowedwa m’malo ndi “Kalongosoledwe kokhudzana zotsatira za masankho ndi zinthu za mavoti.”

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuchula dzina lakuti zolembedwa za pambali zicititsa kukhala kosavuta kumvetsetsa mwakucotsa liwu “zoyembekezera.” Lamulo lakumbuyo la zolembe za pambali linali kungocititsa zotsatira zosakhalitsa pa malo oponyera mavoti. 29. Amendment of section 72 / Lamulo Lokonzedwa 72

Lamulo ili likusinthwa mwakucotsa Cigawo 72(1) ndipo likunena kuti nchito za *returning officer* pambuyo polandira zinthu za masankho pansi pa Cigawo 71. M’mawu osavuta, pambuyo poti returning officer watenga zotsatira za masankho kucokera *m’mapolling station*, ayenera kuwerengera ndi kulinganiza zotsatirazo pa konstichuwensi, pa cigawo kapena pa wadi, ndipo pambuyo pake kupenyetsetsa momwe zimenezo zilili m’njira yomwe lamulo limafunira. Colinga cacikulu ca dongosolo losungira zotsatira za masankho kukhala zomveka bwino ndipo ndi kucititsa mawu a lamulo mogwirizana ndi masankho motsatira lamulo.

Polinganiza ndi Cigawo 72(1) cocotsedwa mu lamulo lakale, lamulo latsopano ndi lalikulu ndipo lili ndi mfundo zambiri. Lamulo lakale limachula cabe za kulengezedwa kwa zotsatira za masankho a prezidenti ndi meya kapena wakumpando wa khonsolo, ndipo linali kungotsimikiza zotsatira za National Assembly ndi masankho a Wadi. Lamulo latsopano limaphatikizapo masankho a prezidenti, Memb.ala wa Paliyamenti, Meya, Wakumpando wa Khonsolo ndi Khansala pa nthawi yolengezera. Ndiponso, limatsimikiza kunena za zotsatira za Membala wa Paliyamenti, Meya, Wakumpando wa Khonsolo kapena masankho a Khonsolo omwe ayenera kutsimikizidwa.

Kodi Cimeneci Citanthauzanji?

Lamulo losinthidwa likukonza kamvekedwe ndi kutsimikiza kwa lamulo m'dongosolo lamasankho. Anthu obweza masankho a returning officer tsopano ndi otsimikiza za malangizo a pomwe zotsatira ayenera kulengezedwa ndipo ayenera kutsimikizidwa, cimenecingacepetse msokonezo ndi kusagwirizana pa konsitichuwensi, pa cigawo ndi pa mlingo wa wadi. Cimathandizanso kutsimikiza kuti mbali zonse zogwirizana zotsatira za masankho dera ndi a dziko zikusungidwa pansi pa kalongosoledwe kamodzi komwe kangacepetse mikangano ndi kucititsa kuti dongosolo la kuwerengera ndi kutsimikiza likhale loona kwambiri.

Kuwonjezera pamenepa, bungwe la Electoral Commission lidzakhala ndi udindo waukulu ndipo lingafune zinthu zambiri zofunikira, kukonzekera ndi kufikira anthu ambiri mu mapulogiramu opitiriza a masankho. Komabe, kupitiriza kwa kacitidwe kameneka kangalimbikitse demokirase mwakupanga anthu odziwa ndi ovota ocita bwino.

31. Insertion of Part VIIIA- NOMINATION PETITIONS

Zoikidwamo za Mbali 8 ~ KULEMBETSA MADANDAULO.

Mawu Alamulo Osavuta Kumva

Mbali yatsopano ya VIA, yawonjezedwa kuti idziwitse za pempho la kulembetsa, lomwe ndi dandaulo loperekedwa ku bwalo lamilandu kapena ku bungwe laulamuliro, kutsutsa za kulembetsa kwa munthu wina pa masankho. Cimenecicimacititsa kuti masankho akhale osakondera mwakutsimikiza kuti ndi anthu okha oyenerezedwa omwe angaloledwe kuima pa masankho. 32. Rules relating to nomination petition - Malamulo Okhudzana ndi Kulembetsa Madandaulo

Lamulo ili likupatsa mphamvu amfumu a Chief Justice kuti apange malamulo momwe dandaulo la nomination petition.

Kodi Cimeneci Citanthauzanji?

Lamulo limeneli limapatsa mphamvu a Mfumu a Bwalo Lamilandu a Chief Justice kuti apange malamulo, kupyolera pa kukhazikitsidwa kwa lamulo, kutsogolera kacitidwe ndi kalongosoledwe kolembetsera ndi kumvera za madandaulo pamaso pa bwalo lamilandu kapena *tribunal*. Malamulo aang’ono angatenge nthawi yaitali kuti alondoledwe, ndalama za ndapusa, ndalama zolipira bwalo lamilandu, pamodzi ndi nkhani zina zilizonse zofunikira ngati kungafunike kuti pakhale cisamaliro cotheka ca madandaulo, ndipo cimacititsa kapangidwe ka lamulo kocitira ndi mikangano ya kalembetsedwe ka lamulo. Coyamba, ilo likumveketsa bwino kuti umboni wa cigawo cacing’ono (1) lili ku Mndandanda Woyamba, osangoti Mndandanda cabe. Cimeneci cikukonza kapangidwe ndi cikupewa msokonezo pomwe Lamulo limenelo lingakhale ndi zambiri kuposa cabe mndandanda. Caciwiri, mu Cigawo cacing’ono (2), liwu

“kusayenereza” lalowedwa m’malo ndi “kuimitsidwa”, limene likusinthazotsatira za lamulo ili. M’malo mocotseratu kapena kucinjiriziratu munthu kuima pa masankho kapena kusangalala ndi ufulu, mawu atsopano akupereka ganizo loimitsidwa mwakanthawi ndipo pambuyo pake kuikidwanso.

Pansi pa lamulo lakale, bungwe la Commission lingapange malamulo a madera oikidwa malire, makonsitichuwensi, mawadi ndi malo oponyera voti. Mawu a lamulo latsopano akucotsa madera kucokera pa mndandanda umenewo, congo mphamvu za bungwe la Commission zimangogwira nchito m’makonsitichuwensi, mawadi ndi m’malo moponyera voti momwe munaikidwa malire.

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuti lamulo latsopano likumveketsa bwino ndi kuika malire pa ulamuliro wa bungwe la Commission kotero kuti malo omwe anaikidwa malire (kuika mamapu m’malo ovotera kapena kuika malire a makonsitichuwensi) kuti ndi nchito yofunika kupenyetsetsa cabe pa malire anthu ovota mwacindunji ndi oimiridwa, kusiyana ndi madera onse pamodzi. Lamulo ili lasintha mawu ena ogwiritsidwa nchito mu malamulo onse. Kulikonse komwe lamulo limagwiritsa nchito mawu “kompatimenti” kapena “kompatimentsi,” mawu amenewo tsopano alowedwa m’malo ndi “buufi” kapena “buutsi.”

Kodi Cimeneci Citanthauzanji?

Cimeneci cikuthauza kuti lamulo lacinitsa cilankhulo cogwiritsidwa nchito mu lamulo cikhale camakono ndi copepuka. Mawu Alamulo Osavuta Kumva

Cikonzero cimeneci cangosintha mitu mwakuikamo liwu “Coyamba” patsogolo pa liwu “Mndandanda.” Kusintha uku sikusiyanyitsa zam’kati mwake mwa Mndandanda [Schedule], koma kungowongolera kuti lamulo limeneli likuloza ku Mndandanda Woyamba.

Kodi Cimeneci Citanthauzanji?

Kukonza kumeneku kukuthandiza lamulo labwino m’kati mwa Lamulo mwakusintha mitu kucokera pa “Mndandanda Woyamba,” kotero kuti lamulo likumveka mosavuta kuzindikirdwa ndi kutsimikizidwa ndi Mndandanda womwe ukunenedwapo. Kusintha kumeneku kukukhala kofunika cifukwa mfundo yaikulu ya Lamulo lomwe poyamba inali ndi Mndandanda umodzi, koma lamulo latsopano likudziwitsa Mndandanda Waciwiri, kuupanga kukhal wofunika posiyanyitsa pakati pa Mndandanda iwiri pofuna kupewa msokonezo ndi kusamasulira kolakwika.

Mawu Alamulo Osavuta Kumva

Mndandanda Waciwiri ukulongosoledwa mmene mipando yosungidwira azimayi, anyamata, ndi anthu operewera kucita zinthu zina agawana pakati pa zipani zandale pa dongosolo la kuimira kolinganizidwa. Bungwe la Electoral Commission silipereka mipando imeneyi mwacisawawa.

Kacitidwe kameneka kamayamba mwakuwonkhetsa mavoti onse auprezidenti wa zipani zomwe zinayenerezedwa pansu pa lamulo. Mavoti okanidwa amasiyidwa cifukwa samawerengedwa. Pambuyo pake, mavoti onse amagawidwa ndi nambala ya mipando yosungidwa m'gulu lililonse kuti apeze nambala yamlingo [target], imene ndi nambala mavoti ofunikira pa mpando umodzi. Mwacitsanzo, azimayi ali ndi mipando 20, anyamata ali ndi 15, ndipo anthu operewera kucita zinthu zina, conco gulu lililonse lili ndi mlingo wake.

Mndandanda uwu umacititsa kuti cikhale codziwika kuti cipani coyamba ciyenera kukwaniritsa mlingo wake wagulu cisanaganizidwe kupatsidwa mipando m'gulu limenelo. Ngati sicikwanitsa kufika pamlingo wake, cipanico cimatsitsidwa pa mbali imeneyo. Pa mipando ya khonsolo, kacitidwe kamodzimodzi kamagwiritsidwa nchito ngakhale kuti nambla ya mipando mu khonsolo iliyonse imasiyana. Mndandanda wa Matebulo umangothandiza kuonetsa kacitidwe kake. Iwo amathandiza owerenga wamba kuti aone mmene mavoti amasinthira kukhala mipando ya azimayi, anyamata, ndi anthu operewera kucita zinthu zina. Mwacidule, Mndandanda ndi kacitidwe kogawana mipando, komwe kamasintha cicirikizo kukhala kuimiridwa kosungidwa m'njira yosakondera.

Kodi Cimeneci Citanthauzanji?

Cimeneci citanthauza kuti mndandanda ukulongosoledwa bwino ndipo njira za masamu zowerengera mipando ya azimayi, ya anyamata, ndi anthu operewera kucita zinthu zina pakati pa zipani zandale. M'mawu osavuta, bungwe la Electoral Commission limatenga mavoti a anthu onse oima ngati prezidenti a zipani zoyenerezedwa ndi kuwagwiritsa nchito pa cipani coyenera. Zipani zomwe zili mavoti oculuka zimatenga mipando yambiri, pomwe zija zili ndi mavoti ocepa zimatenga mipando yocepa kapenanso olandira ciliconse.

Poyamba, mipando imawerengedwa pogwiritsa nchito *target* [kapena nambala yoikidwa ya mavoti ofunika pa mpando umodzi]. Ngati cipani cili ndi mavoti "otsalira" pambuyo potenga mipando yonse, mipando ija yotsalira imalinganizidwa ndi zipani zina, ndipo mipando yotsala imapatsidwa ku zipani

zomwe zili ndi mipando yotsalira yambiri. Ngati pakhala kulingana pakati mpando wothera, umenewo umaganizidwa mwaciswawa.
